#### CPD...what, when, why and how

Continuing Professional Development (CPD) is one of the main on-going obligations an agent must undertake on a yearly basis. Almost every profession has the requirement for on-going education and training.

The legislation and all guidance materials released by NSW Fair Trading, state that an agent must complete 12 points of CPD training in the agent's calendar year and that those 12 points essentially can, at a minimum, be obtained in a period of no less than 4 hours.

An article that was released this week from Domain.com.au explored some numbers from a Fair Trading audit that showed 1 in 5 agents audited had not completed their CPD training.

If CPD was a new concept then it could be understandable that maybe you can forget or not know that you have to complete the training. However, it is not new and when you renew your Certificate of Registration or Licence on an annual basis, you are required to answer whether you have completed your CPD training or not. This means, based on statistics from Fair Trading that 1 in 5 of the agents audited selected the box to say they have completed the training, when in fact they have not.

Continuing Professional Development should be used, and was designed to ensure, that agents are able to keep up-to-date with the legislative changes within your industry. You work in an industry that is constantly changing and the ways that you learn about the changes and how to implement these changes within your office should be coming from your CPD training.

What is somewhat more disturbing than not doing your CPD training, is "doing" your CPD training that has no industry relevance, no legislative guidance and no learning for your job role.

Many CPD providers are allowing their agents to participate in a ten minute CPD session where the assessment component of that training is a customer service survey about the RTO. This is not going to help you understand the legislative and regulative issues in your industry, it is not going to help you avoid underquoting or even understand deficiencies in your agency compliance.

Choosing to attend a training session on what you should wear for the job and how to consistently call contacts on your phone for the

first three hours of your morning is not going to keep you compliant or teach you what the industry changes are and what you as agent are facing in the coming year, and what it will mean for your business. The point of attending this training is to learn and develop your skills and knowledge as an agent.

Our trainers this year are giving a recap of some of the legislative changes that have occurred in the last 12-18 months for the property industry and are amazed at the number of agents that are not aware of changes regarding property inspection reports, just to mention one topic. These changes occurred in August of last year and have been fully enforceable from that time. This is the point of attending industry and legislative specific training. It might not sound exciting but it will keep you from being fined or losing your ability to work within the industry.

While some training providers will offer you training at a much lower rate, you need to always remember that you get what you pay for. Pay for someone who is qualified to discuss the industry, pay for someone who has researched the legislation and pay for someone that actually cares about their agents knowing what is the right and wrong way to conduct their business within the property industry.
